1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The College has a well stated vision and mission in accordance with both the regional and global requirement. Initiatives are taken up by the College to make the curriculum effective as per the norms of University. Some of the teachers are working as Members on Board of Studies and Board of Examiners. Students are created awareness on issues of national importance like human values & professional ethics, Indian culture etc. The college conducted subject related Seminars and Workshops. Short term Courses in Computer application, Communicative English, Language-Lab Classes are opened for students. Certificate Courses are Indian Culture, Life skills, E-filing returns and Rural Development which are meant to inculcate various skills in students are being introduced. Environmental Studies and Indian Constitution are made as a mandatory subjects in all Programes as per university norms.

All kinds of academic activities including Principal's Meetings, Departmental meetings, preparation of Time-table, Syllabus distribution are as per the academic calendar of the University. Remedial coaching Classes are conducted for the slow learners of SC/ST/OBC categories. Various curriculum and non curriculum programmes are conducted to encourage and motivate the students to improve their academic standards. Within the stipulated time, Monthly Test, Open Book Test, Quiz, Industrial visits and Educational Tour are conducted. The transparent and accountable feedback is obtained from each student about each faculty. Faculty members are provided with the copy of feedback to improve the required modifications in Teaching-Learning standards of both teachers and students in the College.

Teaching-learning and Evaluation

The College strictly follows the rules and regulations of the University and State Government. Transparent and systematic mechanism is adopted in the admission process. The Institution has given preference to the students of economically and socially backward and differently abled. The teaching learning, participative learning methods adopted are student centric. **Lesson plan** is prepared by the individual teachers to schedule their teaching and evaluation as per the academic calendar. **Remedial, Spoken English** classes are conducted for poor performing students in order to enhance their skills by proper Mentoring system. Every student is taken care in all respects by adopting **Mentor-Mentee system.**

Examinations at various levels, evaluation, assessing and awarding **internal marks** to the students are transparent and accurate which is as per the norms of the University. The attainment of **POs**, **PSOs and COs** are measured through the results and satisfaction survey summary of the stakeholders. The grievances of the low achievers are attended, recommending them for revaluation or reappearance of examination. The curriculum development, evaluation process and reforms and the feedback from the students are instrumental in bringing out the necessary changes in the practice of the College for further improvement. Faculty members from various disciplines have presented their research papers in the National and International Seminars/Conferences and their papers have also been published in the refereed journals. The Library has abundant number of books, journals and e-resources through INFLIBNET.

All Departments are provided INTERNET facility. **03 Ph.D., 04 M.Phil**. Degree holders are working, 02 faculty members are in Ph.D. perusal. The College has conducted Knowledge sharing-Consultancy programmes to the aspirants in the society. some extension activities on the concept of Organic Agriculture, Organic food, World Soil Day, World Envioronmental day, Sadbhavana day, Swachh Bharath Abhiyan, Heritage awareness programme, Alcoholic-de addiction, Health awareness programme, distribution of Wheel chairs to the disabled and Blood donation camp organized by Youth Red Cross unit in association with NSS, NCC, Bharath Scouts & Guides and IQAC.

Students are sensitized and made aware of their responsibilities through community service programmes organized by NSS, NCC, and Bharath Scouts & Guides and Physical Education which inculcate human values in students, above cited activities are being conducted to meet the vision and mission of the Institution.

Infrastructure and Learning Resources

The College has excellent physical facility. The buildings of the College are built with 4465 Sq. mts, out of 5.24 acres of the total land with lush green garden, Trees and Plants. Total 49 rooms including 18 Class rooms. Management has taken all care in building campus with all amenities. The College has adequate facility for teaching-learning which has created learning ambience in the campus. The college has a Seminar hall/Auditorium with all needed facilities, well equipped Computer Labs, Internet browsing centre, Geography Labs and Language Lab, the college has provided 20KV Inverter and 25KV DG set for continuous supply of power, Library has 26,238 books on various subjects, students and teachers can access e-journals and e-books through INFLIBNET the Library has developed integrated Library management system, Clarity English Software for communication skills, Educational CDs and DVD' are available in the library, in addition to these IT facilities are upgraded and LCD projectors, printers, electronic podium and other electronic equipments are provided to promote modern technology in education. Adequate budgetary provision has ensured the proper maintenance of infrastructure and academic support facilities.

Hostel facility for girl students. Besides, Open Stage, Indoor and outdoor sports facility, Yoga and Meditation centre, Multi- Gym and Basket Ball Court facility are provided. Ramp facility is provided for differently abled students. The College campus is under surveillance of CC cameras.

Thus, provision of adequate physical and academic support resources facilitates smooth teaching, learning, co-curricular and extra-curricular activities.

Student Support and Progression

The College admission process is fair and transparent.. The students strength for the current academic year is 404 (304 Girls and 100 boys) majority of the students are from rural area. The College extends its support to the socially and economically weak students, especially SC, ST, OBC, Minorities, differently - abled and merit students in admission adhering to Government norms. Students receive scholarships from State and Central Government. The Management awards cash prizes for meritorious students.

Remedial coaching classes for slow learners are conducted to get through the semester. The co-curricular and extra-curricular activities are organized by the college. The **Placement and Career Guidance Cell** prepares students for employment through off the Campus Drives; intensive coaching classes for competitive examinations are also conducted.

The grievances and requests of the stakeholders are addressed by the **Grievance Redressal Cell.** The **Anti-Ragging Cell** publicizes its stand - Ragging is strictly prohibited in the campus to curb the menace of ragging. **Sexual harassment** is unheard in the campus. Nature Club, Heritage Club and ELC Clubs are supportive to students' in extra curricular activities. Department of Physical Education is involved in various sports activities. Study tour, Industrial visits, Book Bank facility is provided. Book Bank scheme is opened for SC/ST students. **Parent - teacher meetings are conducted twice in a year.** Students are motivated to exhibit their hidden talents through publishing their articles in the college magazine "**NENAPINANGALA**".

Governance, Leadership and Management

Goals and objectives of the College are as per the objectives of Higher Education which reflect the quality parameters - inculcation of values to promote competencies and match National and Global requirements through academic activities aiming at excellence for local and national development. The leadership is provided by the Management to implement the various activities in the College. The Governing Council of the College Headed by the Chief patron His Holiness Jagadguru Sri Shivarathri Deshikendra Mahaswamiji observes the academic standards of the Institution. Human resource, recruitment policies, procedures, rules and protocols are followed through the appropriate mechanism. Leaders at various levels from the Principal and to the student leaders are well trained to participate in functions for organizational development and effective management. The College decentralizes the power and responsibilities among the faculty members in developing and drafting policies and strategic plans for teaching learning. Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	The college is getting ready to upgrade its laboratory facilities, infrastructure, and other areas of quality improvement in preparation for the National Education Policy 2020's sudden implementation. Training teachers in national education policy is the first action performed. The college plans to establish more short- term courses in order to address the issues that the students confront and to enhance their all-around abilities. Mentoring students is also one of the practices of the institution, to enable students disciplined and confident and help them get the most of their studies.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	Giving importance to the regional and national languages, the college has given option to choose the Kannada, Hindi, Sanskrit and English languages. Preservation and promoting of languages is one of the target of the College in future. In addition to the above to inculcate culture of the country we have

	introduced a short term course - Bharathiya Samskruthi for both the programmes.
5. The college fosters academic and careers success through the development of critical thinking, effective communication, creativity and cultural awareness. Distance education/online education:	The College could able to manage classes during pandemic period through online by using various digital medias like Google Classroom, Zoom, Google meet, using videos as teaching and learning aids. The college is also trying to begin vocational course through ODL (Open Distance Learning) mode in due course of time. Group collaboration and interaction and assignment and revision as well as the assessments are some of the institutional efforts towards blended learning.

Yes, Electoral Literacy Club (ELC) has been set up in the institution in 2018 and is functioning along with department of political science. The Principal is the Chairperson of the Club with HOD of political science as the Faculty Coordinator. Five Teachers and Three students are members in it. VISION: Electoral literacy club aims at strengthening the culture of electoral participation among young and future voters. MISSION: 1.This club's mission is to educate and inform students about their democratic rights. 2.To acquaint targeted populations with EVMs and VVPATs and to educate them about the EVM's resilience and the electoral process's integrity when utilising EVMs. 3.To develop a culture of electoral participation and maximize the informed, and ethical voting, and follow the principle 'Every vote counts' and 'No Voter to be Left Behind' The primary objective of the club is sensitizing the student
	community about democratic rights which includes casting votes in elections.

2. Whether students' co-ordinator and co-ordinating faculty members are appointed by the College and whether the ELCs are functional? Whether the ELCs are representative in character?

Yes, The ELC has both faculty coordinator and student coordinators, appointed by the Head of the Institution. The ELC is functioning with the following Objectives: 1.To educate the targeted populations about voter registration, electoral process and related matters through hands on experience. 2.To familiarize the targeted populations with EVM and VVPAT and to educate them about robustness of EVM and integrity of the electoral process using EVMs 3.To help the target audience understand the value of their vote to ensure that they exercise their suffrage right in a confident, comfortable and ethical manner 4.To harness the potential of ELC members for carrying the electoral literacy in communities 5.To facilitate voter registration for its eligible members who are not yet registered.

3. What innovative programmes and initiatives undertaken by the ELCs? These may include voluntary contribution by the students in electoral processes-participation in voter registration of students and communities where they come from, assisting district election administration in conduct of poll, voter awareness campaigns, promotion of ethical voting, enhancing participation of the under privileged sections of society especially transgender, commercial sex workers, disabled persons, senior citizens, etc.

An Electoral Literacy Club is a platform to engage college students through interesting activities and hands-on experience to sensitise them on their electoral rights and familiarise them with the electoral process of registration and voting. ELCs are also present in colleges and rural ommunities. At ELCs, learning meets fun. Activities and Games are designed to stimulate and motivate students provoking them to think and ask questions. Through ELC, Election ommission of India, aims at strengthening the culture of electoral participation among young and future voters. The following are the initiatives undertaken by the ELC of the institution. 1. Pledge Right to Vote-Awareness in the institution and in nearby villages. 2. Quiz, Debate, Speech, osters making Rangoli and Drawing Competitions to our college students. 3. Voters awareness campaign. 4. Participation in Election Duty Promotion of Ethical Voting. 5. Promotion of Voting among Senior Citizens. 6. Voters Day Celebration.

Response:

JSS College of Arts and Commerce Gundlupet imparts quality education to empower students to excel in their field of choice, to meet the global challenges and install in them a sense of social responsibility. The supportive infrastructure, well resourced laboratories and ICT enabled classrooms create an overall intellectual academic ambience. The institution is affiliated to the University of Mysore. The academic curriculum of all subject framed by UOM. For academic flexibility to introduce certificate courses HOD's of all department takes initiatives. The college is bound to follow and implement the same. The institution has developed a structured action plan for the effective implementation of curriculum. Meetings are convened by the principal at the beginning of academic year to discuss the effective deployment of syllabi. Meetings are convened at the department level by HOD with faculty for allocation of syllabus, discussion and execution of course during the semester and all details documented. Allocation of the subjects to the faculty is done taking into the consideration of subject specialization of the faculty, their experience and willingness. A teaching plan is prepared at the beginning of the semester and delivery of the curriculum is adhered to that schedule. The HOD's monitor and verify whether the teaching plan is strictly followed by each faculty and give valuable suggestions for the effective delivery of the curriculum. If for any reason, classes cannot be held as scheduled and loss of working days for any unforeseen situations, then a contingency plan is prepared to cope up challenges arising out of these extraneous situations. To ensure learning outcomes of each subject, continuous evaluation and internal assessment is carried out through presentations, assignments, case study, class tests and group discussions. various innovative and modern techniques are used by the faculty members which include Google meet, Industrial and Field visit, study tour, usage of digital media for submission of assignments and so on. Students mentoring system is available in the college to monitor students strengths and weakness. At the end of the academic year feedback will be collected from the students on curricular issues, college infrastructure and administrative matters. Feedbacks are analysed, valuable suggestions are considered and necessary actions will be taken. IQAC designs and prepare academic calendars of academic events and action plan with reference of calendar of university. The college library is updated with new additions for effective implementation of the curriculum through easy accessibility. The main aim of the college is to support the overall development of the students in physical, mental and spiritual aspect through Yoga, NSS, NCC, Youth Red Cross, Rovers & Rangers and through various clubs and centers. The learner-centric Choice Based Credit System was followed from 2018. Outcome Based Education – OBE was implemented in the college. 2.3 Teaching- Learning Process

2.3.1

Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

The presence of Information and Communication Technology (ICT) undoubtedly allows new ways of learning for students and teachers and helps the latter to interact with students The institution has arranged for the use Audio-Video tools and ICT enabled class rooms. This facility is made available both for the benefit of teachers and students. They are encouraged to supplement their day-today teaching –learning activities by using the filmstrips, movies and pictorial materials as per the requirement of the content imparted to the learners. Hence the institution has adopted a blended policy of ICT enabled teaching along with chalk and talk method to make the learning process interesting and effective. The use of ICT in the teaching-learning process is very important as it provides opportunities for teachers and students to operate, store, manipulate, and retrieve information.

- Teachers are using IT enabled learning tools such as power point presentation, video clippings and online sources to expose the students for advanced learning.
- Most of the departments are equipped with modern teaching aids like laptops, desktop PCs, LCD projector, internet facility, charts, etc.
- The Seminar hall is equipped with an LCD projector in addition to other seven classrooms, a smart board in the UG Class & three laboratories are provided for the benefit of imparting quality education.
- Adequate number of e-journals and e-books (INFLIBNET) are available in the library.
- "KOHA" integrated library management system (partially) service available.
- All the departments conduct seminars, workshops and guest-lectures on the new developments in core subjects where ICT enabled tools are used.
- Opportunities are provided for students to use LCD projector and internet to present their seminar topics.
- Computer competence is a major factor to integrate ICT in teaching. Hence, training is imparted to the teachers in the use of computers with the help of tech savvy young teachers.
- Educational CDs and DVDs are made available as learning materials. The institution conducted remedial classes for slow learners using ICT. Internet-based learning is used to present learning materials.
- Mobile gadgets such as smart phones are used by teachers to create chat groups and what's app groups to share the course materials, audio, video lectures as well as clarify students' doubts.
- Instead of teachers lecturing for long hours and merely delivering the information, the course material is delivered online to the students beforehand and the classroom is used mostly for peer-to-peer and student-teacher interactions.

2.5 Evaluation Process and Reforms

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

At the beginning of the semester, the HOD's and faculty members inform the students about the University norms for the award of internal assessment marks, rules and regulations pertaining to the internal assessment tests and university examination. An Examination committee is formed at the college level which monitors the overall internal assessment process. The centralized internal assessment tests are conducted for all the students of all programmes. The internal assessment test schedules are prepared as per the Academic Calendar of the college and the dates are communicated to the students well in advance.

CBCS pattern of Examination 80 Theory and 20 IA Marks one test and one assignment as per the University Rules, NEP pattern of Examination 60 Theory and 40 IA Marks (Test, Assignment, Project work, Viva Etc) as per the University Rules.

The University circulars regarding the norms related to the course wise examination patterns are communicated to the faculty members from time to time and are also displayed on the notice board for the attention of the students.

The seminars and group discussions are the regular features. They are conducted by the course teachers. The seminar presentation is evaluated on the basis of the nature of presentation, selection of the topic and the language competence. The internal examination is also conducted for practical courses the day to day performance of the students is assessed by considering regularity, performance, viva and the promptness in submitting the records.

The valued answer sheets of tests are shown to all students and the answers are also discussed with the students. The students are free to interact and resolve grievances if any, regarding the assessment. All the

teachers also counsel the students regarding their lapses if any in answering the questions and help to improve later.

The assignment questions are discussed with the students to get a fair understanding before attempting to answer. The marks obtained by the students in internal assessment tests are disclosed duly before the marks is actually uploaded on the university web portal.

The semester end practical examination shall be conducted with Internal and external examiner from other colleges as decided by the BOE of the respective programme. At the end of each semester, the Principal verifies the Internal Marks of all students. Faculty members also discuss with students about the pattern of question papers of the university examination and prepare them for the main examination.

Remedial classes are conducted to improve the academic performance of slow learners. The college conducts internal assessment and if necessitates make up test for the slow learners are given to help the students to make improvement in the internal assessment marks. The field visits, maintenance of practical records and the behavior of the students also account for the award of the internal assessment. Thus the award of IA is transparent and impartial.

The details are presented for discussion with the Principal. A detailed copy of the syllabus with the course outcomes along with the course and programme outcomes are displayed on the college website after getting the approval from the principal.

Every department documents the POs, PSOs and COs and displays on the department notice board.

The Text books carry the Spelt out objectives of the BOS and also the remarks of the Editorial Committee highlighting the hopes and aspirations of the prescribed curriculum. Hence the students are made aware of the learning outcomes. In the beginning of the academic year during the orientation programme the principal and the staff also drive home the stated CO's and PO'S in lucid ways.

Every Course teacher in turn conveys course outcomes, scheme of evaluation, components of IA, etc. to the students at the introductory lecture of respective course. In some programmes, bridge courses are conducted to help the students to make a smooth transition and enable them to cope with the academic demands of the institute. A hard copy of the syllabus is always available with the department for immediate reference. The students are advised to have a copy of the entire syllabus of a particular semester.

The Institute conducts and encourages faculties to attend the Orientation Programmes and Refresher Courses, workshops, seminar, Short-Term courses and interactive sessions with the experts from the academic field to make the course component more relevant and help the members of the faculty to gain professional competence.

The department level meetings are conducted to take stock of the progress of a course and a review is done at the end of the semester. This helps teachers understand and deliberate on the possibilities and limitations of a course and the learning outcomes. The feedback from students is taken at the end of the programme to assess the effectiveness of the programme outcomes.

The alumni are invited at various events as chief guests to interact with students and teachers. The alumni share their experience on how a specific course helped to shape their career. This encourages aspirants to look positively towards the outcomes of the programme.

department notice board Faculty writes the CO's by referring to the revised Bloom's Taxonomy for their respective course and maps with the PO's by preparing the CO-PO Mapping matrix. Each course outcome is mapped to PO.

Every department conducts meeting to set the attainments levels and assesses the levels achieved for each of the programme offered. Faculty prepares course file which has the following documents; course outcomes, syllabus, notes, question papers, scheme and solution. The attainment level for courses is set based on the previous performance. Each course may have different targets and attainment levels set by the respective course instructor. Setting the attainment levels will help to determine the attainment of each CO against set target. If the required attainment has not been achieved, the course instructor makes an attempt to fill the gaps by taking remedial measures.

Analysis of attainment of PO, CO & PSO indicated the progressive increasing of passing percentage. Joining to higher education percentage has also increased. Student's placement is also consistently increased

3.4 Extension Activities

- Salary of aided employees is provided by the Karnataka Government through salary grants.
- Salary of employees other than aided is provided by Management.
- For conducting of conferences, seminars, workshops, financial resources are mobilized from Management and other organizations such as Banks, Industries, UGC and other funding agencies by associating them for such events.
- The teachers of the college also provide financial assistance for poor and downtrodden students facilitating their admission.
- Donations and grants received from JSS Mahavidyapeetha for CSR activities are provided to the college to meet the deficit.
